
The attached memorial by the Judges of the Court of Appeals, Division One, ably expresses the feelings of the members of the Court toward Jack L. Ogg. Therefore,

In Memoriam

Jack Leroy Ogg, a former judge of the Arizona Court of Appeals and the Yavapai County Superior Court, passed away on February 23, 2011.

Judge Ogg was born in Oklahoma on September 27, 1920. His family moved to Prescott, Arizona in 1925, where he grew up. After graduating from Prescott High School he attended the University of Arizona, where he was elected student body president and was a champion wrestler. Judge Ogg then joined the Army and fought in Europe. He was twice wounded in action. He was also captured by the Germans, but was able to escape and return to the Allied lines.

Returning to Arizona, Judge Ogg attended law school at the University of Arizona. After graduation he returned to Prescott to practice law, recalling later that in his first month he made \$5.50 in fees. He also served as deputy county attorney. In 1958 he ran for Superior Court judge, defeating a long-time incumbent. For the next fourteen years Judge Ogg was the only superior court judge in Yavapai County, handling all criminal, civil, juvenile, probate and mental health cases. During this time he also served as a judge of the Hopi Tribal Court.


In 1972 Judge Ogg ran for and was elected to a seat on the Arizona Court of Appeals, Division One, again defeating an incumbent. He served on the Court of Appeals until his retirement in 1985, authoring almost 300 published opinions. During this time the court doubled in size, and Judge Ogg was instrumental in the orderly development of the court. He was selected by his colleagues to serve as Chief Judge for two years, sat several times with the Arizona Supreme Court, and continued to serve occasionally as a trial judge.


Judge Ogg was widely recognized for his integrity, intelligence, humor and love of people. His life of service as a judge and citizen was an inspiration.




